

- Arts & Craft booths paying the special \$150 booth fee may not sell any Manufactured or Mass-Produced items.**  
 Only goods that are hand crafted may be sold in these booths. Any participant who violates this eligibility criteria will be asked to leave the Faire and will not receive a refund.
