Return this Application/Agreement with the following:

1. Total booth fees in check, money order or credit card. (We accept VISA, Master Card and American Express) Make checks payable to the Manteca CVB.

No personal checks will be accepted after March 2, 2011

2. A stamped, self-addressed envelope. If one is not provided, we will assume that you do NOT want a receipt or confirmation letter.

3. A complete menu of all items you would like to sell.

4. A completed Food Vendors Permit.

Any booth needing power may bring their own generator. It must be a quiet, newer model, and it must not disturb your neighbors.

All Food Booths must have a fire extinguisher and a posted health certificate in booth. **No exceptions.**

Overnight security will be provided, however neither the CVB, Faire Organizers or our Sponsors will be responsible for lost or stolen property.

Your final confirmation will be mailed to you in March '11.
