Rules and Regulations

- Event will go on rain or shine. No refunds if inclement weather.
- No weapon of any type, including knives, guns, caps, or any drug paraphernalia, will be sold at the Faire.
- Food items to be sold must have preapproval by Committee.
- Must post in booth: Health Checklist and Resale License.
- Must bring own Fire Extinguisher.
- No vehicles after 8 a.m. and before 5 p.m.
- Food must be tightly packaged when sold.

- Animals on leash are acceptable; must clean up pet excrement.
 - May use generator, provided it is quiet and gas powered.
 - No tear down before 5 p.m. on Sunday.
- 1) Limited overnight security available. Faire not responsible for lost or stolen items.
 - 2) Faire opens to the public on Saturday and Sunday at 10 a.m., and closes at 5 p.m.
 - 3) Complete final packing, and be off Faire site by 7:30 pm on Sunday.
 - 4) Streets will be open to the public at 8 p.m.
 - 5) The Committee reserves the right to deny booth rental, and suspend a vendor from selling items not preapproved.
 - 6) This Faire is a festival offering arts, crafts, resale, and commercial items including food and entertainment.
 - 7) Additional \$100 charge will be applied for booth left messy.
